### **What is a Form 1095-C?**

Form 1095-C is a tax form required by the IRS to be provided by Edward Jones to its associates. The form contains detailed information about the health coverage offered to you by Edward Jones and whether or not you enrolled in the Edward Jones Medical Plan for all or part of the 2025 calendar year.

### **Who receives a Form 1095-C?**

Edward Jones is required to send a Form 1095-C to any associate who was eligible for health coverage under the Edward Jones Medical Plan during the 2025 calendar year. Additionally, Edward Jones is required to file copies of the form with the IRS.

### **Why do I need the Form 1095-C?**

Your Form 1095-C will confirm your eligibility and, if applicable, your enrollment in qualified health coverage for all or part of 2025. You may need the Form 1095-C to complete your 2025 tax return. Edward Jones does not provide tax advice. You should consult with a qualified tax professional for advice regarding your personal situation.

### **What should I do with my Form 1095-C?**

Your Form 1095-C should be kept with your tax documents. You may need the Form 1095-C to complete your 2025 tax return. Edward Jones does not provide tax advice.
