

## **SUMMARY ANNUAL REPORT FOR EDWARD D. JONES & CO EMPLOYEE HEALTH & WELFARE PROGRAM**

This is a summary of the annual report of the Edward D. Jones & Co Employee Health & Welfare Program, a health, life insurance, dental, vision, temporary disability, long-term disability, and death benefits plan (Employer Identification Number 43-0345811, Plan Number 501), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has insurance contracts with Hartford Life and Accident Insurance Company, Hawaii Medical Service Association, and Metropolitan Life Insurance Company to pay certain long-term disability, health, prescription drug, PPO contract, life insurance, temporary disability, and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$36,394,071.

### **For EDWARD D. JONES & CO. PROFIT SHARING AND 401(K) PLAN**

This is a summary of the annual report for EDWARD D. JONES & CO. PROFIT SHARING AND 401(K) PLAN, EIN 43-0345811, Plan No. 001, for period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$573,126,545. These expenses included \$1,156,423 in administrative expenses, and \$571,970,122 in benefits paid to participants and beneficiaries. A total of 57,189 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$8,685,011,392 as of December 31, 2022, compared to \$10,274,767,181 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$1,589,755,789. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$1,016,629,244), including employer contributions of \$300,538,340, employee contributions of \$497,212,451, earnings from investments of (\$1,879,656,563), and other income of \$65,276,528.
